## TREASURER'S REPORT – J. Barry

- ✓ Both the Association Statement and Tax District Statement of Income & Expenses are tracking well.
- ✓ Land Lease Bank Loan expected to be paid off by June 30, 2017.
- ✓ Major road paving will probably commence in July once curbing and other repairs are completed. C. Wall questioned whether the Rt. 44 gate would be opened during repaving as there is not enough room for two cars to pass. Also turning right or left onto Rt. 44 would be a problem. When asked if the APD had any restrictions on the gate opening, Officer Reardon believed it did not, but will check with the Department's Traffic Officer and report back to R. Markham.

## MANAGER'S REPORT - complete report filed with minutes

C. Rossetti questioned whether FHA mortgage approval had been revoked at Pond Place. R. Markham replied that there never was absolute approval, only case by case. It gets complicated due to the timing of land leases vis a vis individual mortgages.

At issue is whether an existing shed needs to be raised off the ground where the front meets the patio. It has been this way for all the time the property has been owned. It would be very difficult to comply. All other cited repairs will be done. The Board will discuss in Executive Session.

## **OLD BUSINESS**

J. Williams questioned what was happening with Stub Pond? The Pond needed to be drained because The State Department of Transportation is working on cleaning/replacing pipes that empty into the Pond. This is the result of an initiative that was addressed more than a year ago by the Board with the help of State Sen. Kevin Witkos.

## **NEW BUSINESS**

S. Jansen noticed extensive damage to the roof of Sartorius Sports. Upon speaking with the owner, she learned that it was the result of an attempted robbery. Do adjacent property owners, particularly those in Pond Place, receive notice of an event like this from the police? Officer Reardon said he had not heard of this particular incident and that robberies occur along Rt. 44 all the time.

## PUBLIC COMMENT

- T. Zema reported that some fence sections have collapsed and that other sections don't look properly repaired. R. Markham will follow up. Also, people not picking up after their dogs. Is there a town-wide ordinance? Officer Reardon replied there is not, but Pond Place can enforce its own rules.
- M. Cox questioned when driveway re-stoning will occur since hers is "down to the dirt." R. Markham said that extensive re-stoning is scheduled to start sometime after spring cleanup. Areas in most need will be done first. She also reported areas where leaves and debris are piling up. R. Markham will follow up.
