TREASURER'S REPORT ASSOCIATION & TAX DISTRICT – J. Barry

- ✓ Both the Association and the Tax District are tracking very well in terms of Common Fee Income and Tax Assessment Income respectively. R. Markham is to be commended.
- ✓ Land Lease Bank Loan initial amount was \$795,000.00; it is presently \$309,000.00 due to systematic additional payments. It might be possible to pay off the entire loan in two years.
- Diversified Financial Solutions, PC [DFS]. When Capstone Management was first engaged, Richard Markham had a partner who handled the bookkeeping end of the business. When the partner died several years ago, this function was taken over by R. Markham, but he needs the services of a professional from time to time. Pearse Hussey, CPA, a principle of DFS, is familiar with Pond Place having once worked for a Pond Place auditor. He would provide bookkeeping and other accounting services as needed and would also provide continuity in the eventuality of a transition to another property manager. It was moved and seconded to engage the services of Diversified Financial Solutions, PC as outlined in their letter to Pond Place Association, Inc. and Pond Place Tax District dated August 19, 2014. Motion carried.

MANAGER'S REPORT – complete report filed with minutes

- ✓ Building Guide. Guide has been distributed to the Board and will be voted upon at the next meeting.
- ✓ Delinquents. All in the hands of the attorney with one scheduled for a "law date" in September.

OLD BUSINESS

✓ Website. J. Williams asked for guidance regarding "language" to describe Sen. Witkos' scheduled appearance at the next Pond Place meeting on Sept. 22. C. Rossetti suggested something like "Sen. Witkos will discuss what government can do for Pond Place regarding issues pertaining to Stub Pond." K. Lazich will expedite Pond Place Press to encourage participation and will coordinate refreshments.

✓ <u>2 Raven Court, M. Bozek.</u> At issue is the continuance of a "non-compliance" color on glass slider replacements installed in July of 2013 in direct violation of a motion by the Board that M. Bozek be required to repaint sliders "in a color approved by the Manager." Failure to submit a plan of remediation would result in a fine of \$10/day [see minutes August 26, 2013]. This was after the Board had rescinded a previous motion to fine M. Bozek \$200 for failure to submit an application to the Design Review Committee before commencing with window replacements in the first place [see minutes July 22, 2013]. R. Markham will follow up with attorney regarding status of fines and further action.
