TREASURER'S REPORT – J. Barry/Shelly Sundie

J. Barry introduced Shelly Sundie, of Accounting Resources, Inc., Glastonbury, CT. Ms. Sundie specializes in non-profit clients. All accounting functions and responsibilities have now been transitioned from Capstone Management to Accounting Resources, Inc.

- S. Sundie distributed copies and reviewed Pond Place Association Balance Sheet; Operating Budget vs. Actual; Association Dues A/R Aging; Land Lease Balance Sheet; and Land Lease Profit & Loss.
- She also reviewed Pond Place Tax District Balance Sheet; Operating Budget vs. Actual; Profit & Loss by Activity; and Tax Assessment A/R Aging.
- Board members requested that Association Dues AR Summary include address codes as in the past.
- ✓ Tax District Tax Assessment AR Summary should also include address codes as in the past.

OLD BUSINESS

✓ <u>Stub Pond</u>: Fisheries Div. of DEEP will inspect Pond in early September to determine whether weedeating carp would be appropriate or effective. Meanwhile, Pond cannot be treated with any chemicals.

NEW BUSINESS

✓ <u>Landscaping.</u> A lengthy discussion followed regarding landscaper's lack of knowledge about when and when not to trim flowering shrubs and trees. D. Zacchio will walk area and provide R. Markham with information to give landscaper for future reference.

PUBLIC COMMENT

<u>Zema – 12 Gray Pine Common</u>: Immense damage has been done to cul de sac he had personally beautified. Everything now torn up and discarded, even bird nests. "Why was it done? Why weren't we given a heads-up?" Mr. Zema stated that "value has been diminished" and "it looks like nothing."

The Board explained that this cul de sac was cleared as part of a re-landscaping project. Nevertheless, many Board members agreed that proximate homeowners should be given some kind of notice, including a notice on the website. It was also agreed that individuals undertake cul de sac plantings at their own risk.

It was moved and seconded that prior to any major landscaping project, landscaper must submit drawings and a plan to the Board in a timely manner for its approval. Motion carried.
