- ✓ <u>Audit Report for Year Ending June 30, 2012</u>. Report was distributed to Board. Both the Association and Tax District received a "clean opinion." That is, no procedural abnormalities or mistakes were noted.
- ✓ <u>Land Lease Financing Options.</u> J. Barry reviewed several re-financing plans which dramatically lowered interest payments over the life of the loan. <u>It was moved and seconded to accept a refinancing plan from Windsor Federal Savings Bank at a rate of 3.875%. Motion carried.</u> J. Barry thanked Assistant Treasurer Carol Glider for her help in obtaining this loan.

MANAGER'S REPORT - filed with minutes

- ✓ <u>Overcrowding of single homes at Pond Place.</u> A lengthy discussion followed about this possible threat to property values and the general integrity of Pond Place. It was agreed that the Board of Governors and Board of Directors have the necessary authority to define density standards within Pond Place. R. Markham will research Town of Avon housing codes and other existing regulations to determine what is applicable. He will draft a "Pond Place Housing Code" for review at the March or April meeting.
- ✓ Building Guide Committee. Chair, Kim Lazich, will schedule another meeting soon.
