TREASURER'S REPORT

- ✓ C. Glider reported for J. Barry that financials were all in order. She also stated that copies of the Audit Report were available and asked whether the Board wanted the auditors to attend the next Board meeting. The Board did not believe this was necessary. C. Glider offered to answer any questions.
- ✓ J. Williams reported that the next Finance Committee meeting is Tuesday, March 6th, 7:00 p.m.

MANAGER'S REPORT - filed with minutes

OLD BUSINESS

- ✓ <u>Website</u>: J. Williams reported that there have been 197 new "visits" to date. D. Zacchio said he received a number of calls saying that having the Building Guide on the website was very helpful. Storm damage information and all announcements will be updated.
- ✓ <u>Claire Bennett-Joseph, 9 Gray Pine</u>: Letter to Board was read by R. Markham. In it, she requests an extension of the repair deadline due to several extenuating circumstances. She intends to comply in the Spring. The Board agreed to extend the deadline to May 15, 2012 at which time repairs need to be completed or fines will revert back to original start date. It was suggested that Ms. Bennett-Joseph make a list of needed repairs, carefully prioritize, and then stick to a plan of action.
- ✓ <u>Thomas Heleniak, 13 Gray Pine</u>: This property is technically in compliance, but will be carefully monitored to assure completion. A comprehensive list of repairs is also needed.

NEW BUSINESS

- ✓ <u>Fire Hydrant</u> at Clover Court is repaired.
- ✓ <u>Gate at Rt. 44</u> has been temporarily repaired; awaiting insurance status. Avon Fire Department should be notified about location of temporary latch.

PUBLIC COMMENT

- Q. Woodchips piled on side of Stub Pond could be hazard as they produce acid when decomposing. This acid may be detrimental to the Pond.
- A. R. Markham will contact Pond consultant to discuss.
- Q. There are many trees throughout Pond Place that were affected by the October storm. These trees are leaning dangerously toward other people's property. Specifically, A. Costello cited trees leaning toward her home from neighbor's property. She has removed many trees on her property at her expense to avoid similar problems with her neighbors. She had McLellan arborists confirm the danger and does not feel comfortable in her home. Should the Association take any action? Can the Board facilitate?
- A. S. Jansen had three tree companies look at the situation and they did not see any problem. If trees lean toward available sunshine that doesn't make them unstable.
- Q. A. Costello disagrees and said everyone is "shocked" when they see the leaning trees. Also, the ground has a drainage problem which makes it worse.
- A. R. Markham and D. Zacchio will personally look at the properties in question, as well as Pond Place in general, and will follow up as appropriate.
