- <u>End of Fiscal Year.</u> Preliminary data has been sent to auditors. There may be some adjustments in figures. If revenues did not become available due to unforeseen expenditures, then certain projected projects in the budget were not completed, were partially completed, or were postponed. This fiscal approach will continue.
- ✓ <u>Northington Meadows.</u> In response to an inquiry from the audience, the structure and rationale for Northington Meadows was explained: It is a non-stock entity funded entirely by Pond Place Association, which is its sole owner and serves as its Board of Directors. This arrangement makes the Pond and the land, totaling 210 acres, exempt from Town of Avon property taxes. A summary of how this entity was formed was requested for the next Board meeting.

- ✓ <u>Design Review Committee.</u> K. Lazich reported that all updates are completed and in computer.
- ✓ <u>M. Bozek, 2 Raven Circle.</u> Several letters were sent to Mr. Bozek regarding window replacements asking him to Cease and Desist, and inviting him to a Hearing at the Board's next meeting, July 22, 2013. Mr. Bozek, who did not submit an application to the Design Review Committee, also did not appear at the Hearing. The Board will discuss further action in Executive Session.

✓ <u>R. Grossi Gift.</u> A letter and gift card were sent and acknowledged with gratitude by Mr. Grossi.

NEW BUSINESS

✓ <u>4 September Way.</u> Bank has reimbursed Pond Place for all money owed. Ownership and responsibility for property upkeep remains unclear. R. Markham will follow up.

OLD BUSINESS

✓ <u>Fence Negotiations.</u> D. Zacchio, C. Rossetti and R. Markham met with owner of Sartorius Sports. Cost estimate for new wooden fence is approximately \$10,000. Pond Place would likely have to proceed "on its own" and be responsible for maintenance. C. Rossetti recommended that the Board obtain the original fence agreement before proceeding. Meanwhile, the existing chain link fence is unsightly and should be removed. <u>It was moved and seconded to proceed with removing the chain link fence. Motion carried.</u>

NEW BUSINESS

- ✓ <u>Snowplow Damage.</u> Several Board members reported that damage in several areas has not yet been repaired. R. Markham will follow up.
- ✓ <u>Street Lights.</u> Glass inserts have now replaced the original plastic inserts to facilitate cleaning.

✓ <u>G. Gianini</u> requested that two spare packets of material given to Board members at meetings be made available to the audience, especially if given advance notice of attendance.
