TREASURER'S REPORT – J. Barry

- ✓ End of Fiscal Year Association Statement of Income & Expense shows an income of approximately \$1,800 over budget, subject to final audit.
- ✓ J. Barry distributed letter from Pond Place Attorneys, DeManche McChristian, LLC, regarding the ability to establish a Pond Place Tax District Capital Reserve Trust Fund for the Benefit of Pond Place Association, Inc. This issue will be addressed at a future meeting.
- End of Fiscal Year Tax District Statement of Income & Expense shows that total expenditures in the following categories came in under budget: Administration; Contract Services, and Maintenance...an indication of prudent management. All subject to final audit.

OFFICER REARDON REPORT

✓ Bears continuing to adapt to human living spaces. Big Y electric grid failure under investigation.

✓ R. Markham is working carefully with accountants to collect audit information. Data should be turned over to auditors by August 1st.

WEBSITE REPORT

✓ 700 visitors to site in June; 502 visitors in July to date.

OLD BUSINESS

- ✓ <u>Lighting:</u> C. Glider questioned whether any decisions were made on lighting project. Answer: not yet.
- ✓ <u>Re-stoning</u>: A lengthy discussion followed about areas where stoning is inadequate or was not completed. R. Markham will follow up with vendor to try to remedy. The Board discussed strategies regarding the scheduling of future re-stoning efforts.
- ✓ <u>Stub Pond:</u> Remediation has not been completed because Fisheries Div. [DEEP] has not yet inspected Pond to determine whether weed-eating carp, as ordered, would be appropriate or effective.

NEW BUSINESS

✓ Big Y supermarket sustained electrical grid accident which will result in installation of temporary generators. These might cause a significant rise in noise level to adjacent properties.
