<u>Association</u>: Eleven months into current Fiscal Year, revenues are tracking nicely. There is an overage under Expenses due to various architect's drawings related to canopy and canopy roofs. There is a segregated account at Windsor Federal Savings out of which Land Lease mortgages are paid. J. Barry distributed and explained his projections for completely paying off the Land Lease Bank Loan balance by October 2017. He was greatly commended for this effort.

Tax District: Y.T.D. tracking looking good. As of May 2015, there is \$226,023.86 in Ameritrade Reserve Fund.

Someone, most likely a real estate agent, opened a "Pond Place" facebook page that uses photos, graphics and text from the Pond Place website, potentially causing great confusion. C. Rossetti declared that such use was "clearly illegal." J. Williams will attempt to seek more information.

OLD BUSINESS

✓ <u>2 Raven Court.</u> M. Bozek asked for clarity concerning type of paint finish used to paint vinyl trim on sliders. Company insists that, while not technically "shiny," paint has to have some gloss in order to stick to vinyl. Absolutely "flat" paint will not adhere and will eventually warp. R. Markham will arrange meeting with several Design Review Committee members and painter to settle problem. M. Bozek asked that fines be rescinded. Board will consider request at appropriate time.

✓ <u>"Hole" in Ground at Pond Place and Gray Pine.</u> C. Wall reported potentially dangerous electric wire exposure and that it must be corrected. R. Markham will continue to determine ownership and resolve.

NEW BUSINESS

✓ <u>Street Light at Butternut Circle.</u> J. Barry reported that light is going on and off. This happens when it's time to replace or is defective. R. Markham will follow up.

PUBLIC COMMENT

- Q. Can anything be done about brightness of lights now being considered?
- A. We will investigate many alternatives including lower intensity LED lights and colored LED lights.
- Q. Can you conduct lighting tests that are not next to each other for better comparison?
- A. Yes.

Q. What is the status of the section of fence behind Arrowhead and Gray Pine? It invites vandalism.

- Someone threw an explosive that caused smoke. It might have come from Walmart.
- A. R. Markham has instructed Tim Duntz to repair and it should be done soon.
- Q. What is being done about considerable trash that has accumulated at 17 Gray Pine?
- A. Tim was told to clean up. R. Markham will follow up.
- Q. Will there be new crushed rock replacement on walking trails?
- A. It depends on financials at end of year whether it's done in this Fiscal Year or next.
- Q. What can be done about huge pile of leaves on way to tennis court?
- A. They will be removed.
