The President convened POND PLACE ASSOCIATION at 7:00 p.m.

MINUTES OF PREVIOUS MEETING It was moved and seconded to accept the minutes of Feb. 23, 2015 as submitted. Motion carried.

OFFICER REARDON REPORT: Bears are out and roaming. Many sightings, particularly on the west side of town. Also, remember to call animal control officer for off-leash dogs in area.

TREASURER'S REPORT - J. Barry

The Finance Committee (D. Zacchio, J. Barry, C. Wall, J. Williams) approved Association and Tax District budgets for Board's consideration. The proposed Association budget will require an annual fee increase of \$15.00; the proposed Tax District budget will require a 3% increase or an average annual increase of about \$43.00 per household. The proposed Association budget provides for a \$1,000.00 contingency for unanticipated expenses; the proposed Tax District budget provides an additional \$30.000.00 to restore the annual reserve to its normal level of \$60,000.00. C. Rossetti asked a series of questions: O. Do we have income from fines? A. Not really. Can't count on it. O. What is the cost of Association audit? A. \$6,000.00 which includes the Land Lease. O. What was cost prior to Land Lease? A. Around \$2,000.00, but now with the Land Lease we need a "Certified Audit." Q. How is Association contingency used? A. We have unanticipated costs such as architect's fees or legal issues. Without a contingency we would need special assessments. Q. Income from Land Lease is not shown. A. All cashflow income goes into bank account and cannot be accessed for working capital. As cash balance builds up, accelerated payments are made to outstanding loan. Q. Can't that be re-negotiated? A. It was difficult enough to get a Land Lease loan in the first place, as they are very unusual.

ASSOCIATION BUDGET

It was moved and seconded to accept the Association Budget as recommended by the Finance Committee. Motion carried; One abstention. The new Association fee will be \$105.00.

WEBSITE REPORT – J. Williams

There were 1600 "hits" in March; new visitor hits were 261. Website was praised as a great service that provides answers to many questions.

Q. Don't consultant's fees belong in Association budget? A. Will research in general ledger.

Q. What is the combined cost of audits? A. \$13,000.00 which is the going rate. Blum Shapiro charged more.

Q. How much more will vendor be paid to relocate vast amounts of snow? A. Maybe \$10,000.00 more.

Q. When will it be necessary to repave roads? A. Roads good for several more years. Maybe when Land Lease is paid off enhanced cashflow could be used toward paving costs.

It was moved and seconded that the Tax District Budget in the amount of \$312,204.00 be recommended to the Pond Place Annual Budget Hearing. Motion carried.
