(the "Association") Rules and Regulations, the Board of Governors hereby amends Article II of said Rules and Regulations by adding the following provision to the end of Section 2 of Article II: Except on the evenings before days of scheduled pick-up or on the day of scheduled pick-up, rubbish and recycling barrels must be stored inside of garages or sheds to promote safety and reduce unsightliness in the community. Units which lack garages or sheds shall store their rubbish and recycling barrels out of sight from roads. **Motion carried.**
