W. Thompson, 4 September Way – Not Present

At issue is a seriously deteriorating house which is in foreclosure – again. A prior foreclosure action was stayed by a last-minute payment from the parents of W. Thompson. Pond Place, however, was liable for approximately \$5,000 in court costs. It was moved and seconded that a letter be sent to W. Thompson stating that the steps on the deck must be repaired by January 31, 2013 or a fine of \$10/day will commence and that all other cited items must be brought into compliance by May 31, 2013 or a similar fine of \$10/day will commence. Motion carried. It was recommended that a copy of the letter be sent to W. Thompson's parents.

PUBLIC COMMENT

J. Beck commented that speeders are avoiding certain speed humps and taking other streets in order to speed through Pond Place. D. Zacchio is aware of situation.

- ✓ <u>Observation Deck.</u> Part of deck facing Pond did not receive recent polyurethane coating. R. Markham is aware and will remedy.
- ✓ <u>Accumulating Debris.</u> Piles of debris are accumulating behind the former Bridal Shop store. A lengthy discussion followed regarding site plan ordinances, regulations and history. Similar conditions prevail behind the Big Y store. R. Markham and D. Zacchio will follow up.

OLD BUSINESS

<u>FEMA Reimbursement.</u> Rules are "stacked against" communities like Pond Place. Costs of litigation make it unlikely that additional reimbursement will be pursued.

NEW BUSINESS

<u>Electric Light Pole.</u> Near Big Y – leaning dangerously. R. Markham will follow up.
