<u>ADOPTION OF FY 2014 – 2015 TAX DISTRICT BUDGET RESOLUTIONS</u> The following resolutions were adopted unanimously:

- RESOLVED: ADOPTION OF BUDGET. That the budget for Pond Place Tax District for the fiscal year commencing July 1, 2014 and ending June 30, 2015 be approved.
- RESOLVED: ADOPTION OF MILL RATE. That the tax for the fiscal year commencing July 1, 2014 and ending June 30, 2015 be affixed at 11.45 mills.
- RESOLVED: LEVYING OF TAX. That the tax for the fiscal year commencing July 1, 2014 and ending June 30, 2015 be levied against all real property situated in the Pond Place Tax District based on the assessments on the Grand List of the Town of Avon as of October 1, 2013, at a mill rate of 11.45 mills provided that there be no tax on motor vehicles.
