The ANNUAL MEETING of POND PLACE ASSOCIATION, INC. was called to order at 7:03 p.m. by Association President, D. Zacchio, and the meeting was then turned over to R. Markham who explained voting procedures and terms of office. A quorum was declared present (members present constitute a quorum). It was the consensus of those present that Notice was given and that Proof of Notice be waived. Board members, property manager and minute taker were introduced.

#### READING OF THE MINUTES OF ANNUAL MEETING HELD MAY 27, 2015

It was moved and seconded to waive reading of the minutes and accept as submitted. Motion carried. R. Markham noted that minutes were sent with Notice and that minutes are always open and available.

# **ELECTION OF BOARD OF GOVERNORS (FOUR TO BE SELECTED)**

The following slate was proposed for a two-year term commencing July 1, 2016:

The Association budget for FY 2016-2017 was duly approved by the Board of Governors at their March 28, 2016 meeting. The new annual Association fee will be \$115.00.

# ADOPTION OF THE FY 2016 - 2017 TAX DISTRICT BUDGET & BUDGET RESOLUTIONS

The following resolutions were adopted unanimously:

RESOLVED: ADOPTION OF BUDGET. That the budget for Pond Place Tax District for the fiscal year

commencing July 1, 2016 and ending June 30, 2017 be approved.

RESOLVED: ADOPTION OF MILL RATE. That the tax for the fiscal year commencing July 1, 2016 and ending

June 30, 2017 be affixed at 11.85 mills.

RESOLVED: LEVYING OF TAX. That the tax for the fiscal year commencing July 1, 2016 and ending June 30,

2017 be levied against all real property situated in the Pond Place Tax District based on the assessments on the Grand List of the Town of Avon as of October 1, 2015, at a mill rate of 11.85

mills provided that there be no tax on motor vehicles.

## **PUBLIC COMMENT**

- Q. Exterior house lighting is remaining on and off apparently out of sync with any Pond Place lighting.
- A. This is a private owner problem and should be addressed by an electrician.
- Q. Will weed-eating carp be introduced to Stub Pond?
- A. An application has been filed with the Department of Fisheries. We are awaiting a reply.
- Q. Will street lighting be extended to some areas not presently lighted?
- A. The Board is considering doing that and is getting estimates.

There being no further business to come before the ANNUAL MEETING of POND PLACE TAX DISTRICT, the President adjourned the meeting at 7:27 p.m.
