- ✓ The history and rationale behind establishing a Pond Place Tax District Capital Reserve Trust Fund for the benefit of Pond Place Association, Inc. was described.
- ✓ Pond Place attorneys, DeManche McChristian, LLC, in a letter dated June 1, 2016, outlined the Board's authority to establish a Capital Reserve Trust Fund.
- ✓ A Resolution prepared by said attorneys was presented to the Board authorizing the President and/or Treasurer to establish an account to be known as the Pond Place Capital Reserve Trust Account and described the Trust Account's numerous details.
- ✓ Several Board members questioned the need for such a complex, separate Trust Account when a simpler, segregated "cash account" would serve the same purpose.
- ✓ *Addition/Correction:* Also questioned was who will have the responsibility for tracking Accounts Receivables/Collections?
- ✓ There were additional questions regarding taxation, investment earnings, restrictions and general exposure of Trustees.
