A VOTE to replace all of Pond Place's light poles, being deep bronze, 4" square, paid from reserves and not to exceed \$70,000.00 was taken. All in favor. Motion Carried.

ADOPTION OF THE FY 2018-2019 TAX DISTRICT BUDGET & BUDGET RESOLUTIONS

The following resolutions were adopted unanimously:

RESOLVED: ADOPTION OF BUDGET. That the budget for Pond Place Tax District for the fiscal year commencing July 1, 2018 and ending June 30, 2019 be approved.

RESOLVED: ADOPTION OF MILL RATE. That the tax for the fiscal year commencing July 1, 2018 and ending June 30, 2019 be affixed at 11.85 mills.

RESOLVED: LEVYING OF TAX. That the tax for the fiscal year commencing July 1, 2018 and ending June 30, 2019 be levied against all real property situated in the Pond Place Tax District, based on the assessments on the Grand List of the Town of Avon, as of October 1, 2017, at a mill rate of 11.85 mills, provided that there be no tax on motor vehicles.
