### Notice & Hearing Girardin, 1 Irontree Court

At issue are possible repeat violations of Pond Place Rules & Regulations, Article III, Paragraphs 3 & 4 which state, in part, "no dog will be permitted in any portion of Pond Place unless leashed and under control of the owner or keeper...." and "No pet shall be permitted to bark...." Nancy Girardin stated that the dog, a Labrador retriever, was younger than she thought and is territorial but not aggressive. The dog is properly licensed and up-to-date with shots. According to the Girardins, the dog is not unattended when tied outside, but actively "watched" from inside the house. It will be neutered in the near future, so perhaps it will "calm down." Mrs. Girardin stated that, when asked, neighbors said they were not bothered by barking. Mr. Gemme concurred, saying that the dog is just a puppy, not aggressive, and never out at night. They asked that fines be excused and stated that they want to comply.

Board members made several suggestions regarding possible use of electronic "shock" collars, and employing the services of a professional trainer. The matter will be discussed in Executive Session. The Gerardins thanked the Board and left the meeting.

Mr. Gemme commended the Board for doing an excellent job.

## MANAGER'S REPORT - filed with minutes

Delinquencies: Largest amounts are for fines; 7 homes are in hands of attorney for foreclosure, and 1 is under court-supervised foreclosure payment plan.

FEMA Reimbursement: Some maintenance items in budget have been "blown away" by October stormrelated expenditures. R. Markham will continue to follow up aggressively to obtain FEMA reimbursement.

#### OLD BUSINESS

Pond Place Press. Will probably be published and distributed March 15th.

Speed Humps. People still speeding. Avon Police Dept. will be contacted to install radar and, if necessary, issue tickets. Humps may need additional work so that elevation on sides are the same as the middle.

Tree Hazards. It was generally agreed that Pond Place should try to mitigate identified tree hazards even when trees are on exclusive use areas. The Board asked R. Markham to send a letter to S. Jansen, 6 Pond Place, "strongly suggesting" that the trees in question be removed.

It was moved and seconded that R. Markham write to N. Girardin, once again stating the existing rules, and underscoring the fact that (1) the dog cannot be tied outside; and (2) cannot be at the end of a leash at any time whatsoever without a person physically holding the other end of the leash. Motion carried.
